OPENING OF REGULAR SCHEDULED MEETING:

- 5. Board Discussion/Action Public Works Director Zack Ratcliff regarding purchasing equipment. Mr. Ratcliff approached the Board regarding the purchase of a Laminated Tailwheel Trailor in the amount of \$5,593.00 and a Kubota Tractor in the amount of \$37,614.17. - 6. Board Discussion/Action Fannin County Fire Chief Larry Thomas & Fannin County Building Inspector Keith Nicholson regarding the purchasing of building for Fire Station #2. Fire Chief Larry Thomas and Building Inspector Keith Nicholson approached the Board regarding the construction of the new Mineral Bluff Fire Station #2. The following quotes were presented for the following phases of construction:

Chairman Hensley presented the cost of the window replacements in the amount of \$111,978.40 to be paid from Admin SPLOST. Chairman Hensley made a motion first to approve the purchase.
